MINUTES OF THE BYWATER NEIGHBORHOOD BOARD MEETING February 2, 2021

The meeting was called to order at 7:15 PM.

Board Resignation

John G. discussed past meeting and the importance of getting the minutes current and posted to the website., which are currently several months behind. John G. nominated Carolyn C. to fill the secretary vacancy created by the resignation of Gabrielle Gaspard due to her relocation out of Bywater. A motion was made by Mary Ann H. and was seconded by Arlene H. to appoint Carolyn C. as board secretary. The motion was approved unanimously.

Finance

Arlene H. presented to Treasurer's Report, which indicated a net income for the month of January of \$209.25.

Markey Park

Mary Ann H. reported that she and Michael Wawrzycki were working to secure a meeting with the lawyer for the city to discuss the indemnity clause on the current draft of BNA's Markey Park agreement with the city. She also reported that a park clean up as recently completed. She indicated that the bamboo removal will be completed once the agreement with the city is finalized.

Home Tour

John G. reported that video shoots for all five houses were completed. Editing is in process. A local musician has also been filmed to be included at the end of the video. He indicated that the cost to view the virtual home tour would be \$15.00 for non-members and \$10.00 for members. Zoning

Mary Ann H. reported that a zoning committee meeting would be scheduled in the coming week to address an application for a conditional use permit at 1032 Montegut to construct a four-flex. The hearing is scheduled for February 23rd and comments are due February 15th.
